Spencer Cox thinks we are stupid.

Phil Lyman won the 2024 UTGOP Convention as governor nominee by 67%. In April, conventional media polls showed Phil 40 points down from Cox. Up to the Primary, polls showed Phil down by 20 points. Phil narrowed that gap to less than 10 points in the June Primary. Had 1100 or so voters in southern Utah not had been disenfranchised due to their ballots being routed to Las Vegas for a postmark, who knows? The gap might have been narrowed further.

Signature Gathering (SB54). Recall that there is an ongoing criminal investigation from signature gathering for the special CD2 race in 2023, namely, fraud, forgery, and improperly collecting signatures. Spencer Cox and other candidates used the same signature gathering company.





All of a sudden, two other people named Lyman magically filed as write-in candidates for the governor race – Richard Lyman and Carol Lyman for Governor and Lt Governor.
